BESIDES BEING AN ALL-TIME RECORD FOR ONE YEAR, THE FY 2016 MEAL NUMBER WAS 12% HIGHER THAN THE PREVIOUS YEAR AND 54% MORE THAN FIVE YEARS AGO. GOD'S LOVE CONTINUED TO SUPPORT THE EFFORT TO REDUCE HEALTH CARE COSTS BY KEEPING SEVERELY ILL AND/OR DISABLED INDIVIDUALS IN THEIR HOMES INSTEAD OF IN INSTITUTIONAL FACILITIES.
