Since I last wrote, we celebrated Pride Month in June, partied with David Burtka and Neil Patrick Harris at Midsummer Night Drinks, and launched our first golf/tennis/pickleball event — The God's Love Open (GLO) — with our friends Roberta Graves, John Idol, and Mike Anthony leading the way.

I'm looking forward to a busy fall season with the New York City Wine & Food Festival followed by the Golden Heart Awards gala in October, and the 30th Anniversary of the Race to Deliver in November. These events do more than raise much-needed funds, they help us build lasting relationships with many wonderful supporters.

In the past year, we delivered 3,639,099 medically tailored meals to 12,783 individuals—a whopping 30% increase from the previous year. I extend a huge thank you to all who helped make this possible including our staff, volunteers and donors. We can't do this work without you.

We were honored to receive a 4-star rating from Charity Navigator for the tenth year in a row, an achievement earned by less than 5% of charities evaluated nationally. This is the highest rating awarded by America's largest independent charity evaluator. The 4-star rating recognizes our strong financial health and commitment to accountability and transparency.

City Harvest & Citymeals Partnerships Kickstart Program and Delivery Expansion

Friends are important, and God's Love We Deliver is grateful for our amazing friends at City Harvest and Citymeals on Wheels. These are two extraordinary organizations who make a difference in NYC—and who, with recent partnerships, help us all achieve shared goals.

For example, with demand for our home-delivered meals increasing by more than 10% each year, God's Love has reached maximum storage capacity at our SoHo headquarters. So we joined forces with our friends at City Harvest, New York City's largest food rescue organization. God's Love now works alongside City Harvest at their Cohen Community Food Rescue Center in Sunset Park, Brooklyn. Through this partnership, we are able to store thousands of medically tailored meals for delivery to our clients living with life-altering illness in Brooklyn, and beyond.

Sharing space with City Harvest, members of our meal packaging team now report to the Cohen Community Center Monday through Friday to pack 20,000 meals per week that our drivers deliver to 1,500 clients in Brooklyn.

This isn't the first time our mission-aligned organizations have worked together to feed New Yorkers experiencing food insecurity and malnutrition. Our work with City Harvest is ongoing. We currently access the amazing fresh produce City Harvest rescues, using their veggies for our medically tailored meals. And, God's Love supplies medically tailored meals to City Harvest for distribution to food pantries and soup kitchens across the five boroughs.

Along with City Harvest, you probably know about the great work Citymeals on Wheels does for seniors throughout the city, and recently God's Love teamed up with Citymeals to provide clients, families, and caregivers with more than 27,000 emergency, shelf-stable meals in the event of service disruption.

While our organizations have a long-standing relationship, this is our biggest partnership with Citymeals to date. We are so happy to share distribution strategies with Citymeals as we move into the colder weather of fall and winter. God's Love President & CEO David Ludwigson says, "It's important that our clients get the meals and care they need, when they need them, no matter the circumstance. Along with Citymeals and City Harvest, God's Love provides vulnerable New Yorkers with a sense of security, so that even in an emergency they have the life-sustaining nourishment they need."

“I make a lot of doctor’s appointments and I proudly say ‘No, not on Wednesday. That’s my God’s Love delivery day and I don’t want to miss it!’” Mark says. “Your meals make me healthier than I was a couple of years ago. I feel stronger and I’m finally starting to feel like myself again.”



FROM THE KITCHEN:

Garbanzos Guisados

It is our pleasure to feature a recipe for Garbanzos Guisados (Chickpea Stew) from cookbook author and friend of the organization Karla Salinari. For weeks I've been thumbing through the many accessible and exciting recipes in her cookbook, *Abuela's Plant-Based Kitchen, Vegan Cuisine Inspired by Latin & Caribbean Family Recipes*, finding fresh culinary inspiration for our clients' meals.

Karla's approach to cooking is a celebration of her heritage, and her flavors are bold and unabashedly traditional. A recipe of Mushroom Ropa Vieja comes alive with cumin, capers and Spanish olives, playing against the earthy chew of oyster mushrooms and subtle sweetness of bell peppers. The same Homemade Sofrito and Homemade Sazón that flavor her Pastelón (Puerto Rican Sweet Plantain Lasagna) also enrich her recipe for Garbanzos Guisados which we recently added to our client menu.

By slightly adjusting the ratio of chickpeas in the recipe and serving the stew with a side of rice and gandules, we raised the amount of protein in the dish, ensuring our clients' nutritional requirements were met for this new medically tailored meal. Please enjoy this recipe—I'm sure it will become a regular part of your rotation, as it has become a part of ours.

From the God's Love Kitchen

Serves 4-6

Prep time: 15 minutes

Cooking time: 20 minutes

Ingredients:

- 1 tbsp olive oil
- 2 tbsp Puerto Rican sofrito
- 1 tbsp adobo
- ½ tbsp sazón
- ½ cup tomato sauce
- 1 (16-ounce) can chickpeas, drained and rinsed
- 1 cup potatoes, cut into small cubes
- 1 medium carrot, cut into small cubes
- 1 cup calabaza squash, cut into small cubes and seeds removed
- 3 cups water
- 1 dried bay leaf
- ½ tsp salt
- ½ tsp ground black pepper
- ½ cup fresh cilantro, chopped

Garbanzos Guisados

Adapted for the God's Love Kitchen in celebration of Hispanic/Latine Heritage Month from *Abuela's Plant-Based Kitchen: Vegan Cuisine Inspired by Latin & Caribbean Family Recipes*

To Serve

- Cooked rice
- Sliced avocado (optional)

Method

1. Heat the olive oil in a pot over medium heat. Add sofrito, adobo, and sazón. Sauté for 2-3 minutes.
2. Add the tomato sauce, chickpeas, potatoes, carrots, and calabaza squash and combine.
3. Add the water, bay leaf, salt, and pepper and mix to combine.
4. Let cook until the stew comes to a boil, then reduce the heat to a simmer, cover, and let cook for 12-15 minutes more or until the vegetables are tender.
5. Once the vegetables are soft, shut off the heat, add fresh cilantro, and combine.
6. Serve with a scoop of rice and slices of fresh avocado and enjoy!







"Food is love. You are delivering love. And having been on the other side of it, I know what that feels like. And how the mission has broadened over the years is incredible. At the height of the AIDS epidemic, God's Love was there. There are so many people who are suffering, alone, or can't get food for themselves and God's Love has not stopped but continues to grow in such a generous and wonderful way."



HEALTHCARE:

Business Development and Community Partnerships Team Assists Clients At-Risk of Losing Insurance



BDCP TABLES AT NATIONAL HEALTH CENTER WEEK HOSTED BY OUR PARTNER RYAN HEALTH.

Access to healthcare is a human right. Unfortunately, those enrolled in New York State of Health (NYSOH) insurance are at great risk of losing that access due to the Public Health Emergency (PHE) ending. During the COVID-19 pandemic, families enrolled in New York State Medicaid, Child Health Plus and Essential Plan did not need to renew their health insurance due to the Families First Coronavirus Response Act. After three years, NYSOH has announced that as of this spring, 6.9 million individuals in New York will need to redetermine their eligibility for NYSOH insurance.

When our Business Development & Community Partnership Team (BDCP) first learned about the imminent end of the PHE, our immediate response was to understand and inform about the implications for our clients. God's Love serves thousands of clients living in highly saturated Medicaid neighborhoods. Knowing that loss of coverage results in a disengagement from care, our clients would potentially be unable to receive our services.

As a team, we internally promoted the impact and risk our clients were facing so that we could identify those who might need assistance in determining their eligibility. Additionally, we ramped up our external outreach efforts to ensure that our partners across the city were helping support our clients wherever possible. We established new linkage agreements with social service agencies such as Community Agency for Senior Citizens, Latino Commission on AIDS, NY Connects: Manhattan at New York Foundation for Senior Citizens, and more

as an effort to ensure that those needing assistance with their renewal would be connected with partner organizations.

Recently, the BDCP team attended the United Health Fund Medicaid Conference to learn about the outreach efforts NYSOH has pursued to ensure no New Yorker is without health coverage. Since then, our agency has been working strategically with our partners to continue supporting our clients through this important transition. As an agency, our mission is to improve the health and well-being of people living with serious illnesses by alleviating hunger and malnutrition, and keeping our clients engaged in care is vital to fulfilling that mission.


